Demonstration: An Exhibitor that does not manufacture or distribute the product being sampled but wishes to use food and/or beverage to demonstrate a piece of equipment is considered a demonstration. Below are the two options to choose from in order to do so.

➤ **Exhibitor Option #1** - Specific Product purchased through Centerplate. Condiments and spices etc. added are not an issue and are ok'd through Centerplate.

- o Minimum size requirement as listed below.
- o All other Centerplate sample requirements are to be met per our sampling guidelines
- o Pricing below ++ = 19% admin fees & 8.375% tax

- ❖ Whole Chicken: (Comes a case with 14 approx. 3lbsea) **\$900++ per case**
- ❖ Chicken Wings (Comes 40lb case) **\$330++ per case**
- ❖ Center Cut Pork Loin: (Comes a case with 2 loin – 9lb average ea) **\$212++ per case**
- ❖ Hamburger Patties: (Comes 45 per case/5.33oz patties) **\$374++ per case**
- ❖ Bacon Applewood Smoked: (Comes 15lb case) **\$485++ per case**
- ❖ Smoked Sausage: (Comes 10lb case) **\$180++ per case**
- ❖ Bratwurst: (Comes 10lb case) **\$186++ per case**
- ❖ Hot Dogs 6:1 all beef natural's (Hebrew National): (Comes 20lb case) **\$408++ per case**
- ❖ Tri Tip Choice or Higher: (Comes a case 68lb average) **\$1,269++ per case**
- ❖ Pork Ribs: (Comes by the case 5/3pc. 2.75lb average) **\$915++ per case**
- ❖ Shrimp (peeled, deveined tail on 41-50) (Comes a case 10lb) **\$348++ per case**
- ❖ Shrimp (peeled, deveined tail on tail on 21-25) (Comes a case 10lb) **\$350 ++ per case**
- ❖ Brisket Whole: (Comes a case – 5pcs 10lb average) **\$1,451++ per case**
- ❖ Ribeye: ea. (Comes a case 3pcs 15lb -18lb average) **\$1,902++ per case**

➤ **Exhibitor Option #2** - 3-Day Show Demo fee of \$600++

- o Exhibitor will see this as a charge of \$200++ per day.
 - o **Limited to sample size of 2 oz. only - This includes meat, fish, chicken, veggies, etc...**
 - o **ALL additional food & beverage must be purchased through Centerplate.**
- A \$50.00+ tax remote location charge will apply for each food and beverage delivery to all parking lot exhibit booths.
 - ****The Remote Location charge applies to ALL parking lot deliveries****
